Legal Career & Prior Experience

Early in my career, I was assigned to work on the probate of a travel agent who was murdered by his fifth wife. Several previous wives filed claims, and a baby was presented as the child of the murderess, therefore as an alleged pretermitted heir. During years of administration, we sold several pieces of real property, litigated many claims, endured an audit of the 706, and sued a bank in Switzerland from which the murderess had stolen money. Ultimately, we proved that – not only had the decedent not fathered the alleged child – but the murderess was not even the child's mother! From that point on, I have concentrated my practice on estate planning and probate litigation.

I have drafted trusts. I have administered trusts and probates. I have completed estate tax returns and I have participated in audits. I have tried cases, and I have been involved in almost every sort of probate or trust dispute there is.
