### **Overview**

John Edwards is a nationally recognized speaker and mediation trainer. After many years as a trial lawyer, John is now a full-time neutral mediating cases throughout Southern California. In conjunction with his mediation practice, John frequently lectures at seminars and law schools, training both lawyers and other mediators in effective negotiation strategies to be used in mediations. He is an adjunct faculty member at Pepperdine Strauss Institute of Dispute Resolution and at the High Conflict Institute, through which he teaches seminars on working with high conflict personalities.

John is often engaged to mediate the most challenging matters in which the legal issues are not driving the dispute, but the personalities are the issue. Lawyers are often frustrated because their usually persuasive legal skills are often ineffective with high conflict people. John has had years of training and experience, and has become known for achieving results when legal analysis and vigorous advocacy have failed to achieve settlement.

In cases in which legal and factual issues are complicated, John's trial and mediation experience provides a foundation to assist the parties in evaluating the relative strength and weakness of both sides of the case. John's polite persistence and commitment to follow through when cases don't quickly settle often leads to settlement when hope had been lost. His ultimate goal is a resolution that leads to client satisfaction with both the process and with their attorneys.
