- Richard is available to mediate cases throughout Southern California.
- For cases in Orange County, Richard requires a minimum of 5 hours, but does not charge for travel time.
- For cases in Los Angeles County, Richard requires a minimum of 6 hours, but does not charge for travel time.

Superior Court Ordered Civil Mediations:

- Civil Unlimited: \$250 per hour for each of the first two hours and \$450 per hour thereafter.
- Civil Limited: \$150 per hour for each of the first two hours and \$450 per hour thereafter.
